<b>Practical-professional profile of the course and industry sector of reference</b>	The course aims to train competent professionals in forensic odontology, professional dental liability, damage assessment, and odontological personal identification. Specifically, the course aims to train Forensic Odontologists whose work will be on behalf of Public Companies, Courts, Insurance Companies, Private Parties, and Disciplinary Boards. To this end, the training will be divided into four modules. It aims to train the participants in the area of health legislation inherent to the dental profession, professional responsibility, ethics and deontology in dentistry, damage assessment in the different areas (criminal, civil, insurance), and odontological identification of the cadaver and the living person.
<b>Access prerequisites</b>	Single-cycle degree obtained according to the system under Ministerial Decree No. 270/2004 (or specialist degree under Ministerial Decree No. 509/1999 equated under I.D. <b>How the admission procedure takes place</b>	Selection by qualifications combined with a multiple choice test to verify the preparation on dental forensic medicine.

<b>Teaching methods</b>	12-14 days of in-person teaching 5-10 synchronous distance learning frontal teaching sessions - WEBEX or GMEET platforms 12-15 distance learning courses and internships through asynchronous teaching using an E-Learning platform (forum, collaborative writing, in-progress testing)
